It was the best of times...it was the worst of times. With the mood swings of Mother Nature this year and last year, you would think we could get a break here or there. We did experience something extremely different as we had insult added to injury with an early arrival of winter conditions and virtually little to none for fall weather to enjoy. Whatever our desire when it comes to weather, will take what we get...and like it...or at least deal with it as best we can.

As mentioned, that weather has been a challenge for most outdoor activities. It certainly did not provide our department with any favors. It has warmed up enough to erase signs of the early snow and allow us to get back on track with yard waste and leaf collections. I would like to commend and thank those who continue to be good stewards and neighbors by placing materials for collection properly on the terrace and not in the street. I also need to point out that we still have residents, or their service providers that place materials onto the street where it is only a rainfall away from flowing into the lake and or clogging the storm system. This year we were only a snow fall away from redistributing the leaves in the street to all of the neighbors downstream, so to speak. Voluntary compliance please; Thank You.

Mentioning outside activities impacted by the weather would have to include private home construction and landscape disturbance. We are witness to so many active work sites that storm water control receives the least amount of attention. What we see ranges from poorly installed or missing control measures. The effort does not stop once the proper appurtenances are in place, it has only begun. These same items require constant maintenance to maintain integrity. Storm water and erosion control receives little or no attention once the project begins. While this should be attended to by the contractor, any fines levied will likely go to the property owner. Voluntary compliance please; Thank You.

One more item regarding active project zones is specific to contractors and the parking of their vehicles and equipment. There is a tendency to swarm the job location and place trucks and equipment on both sides of the street creating a hazardous driving condition or an impossible pass through for emergency vehicles. Please request that your service providers park on your property or on one side of the street to allow for better traffic flow. Also, inform them that there is an ordinance that requires a permit to occupy right of way. We see contractors dumping materials onto the street; equipment parked over night; downing of trees onto the street. These actions without prior consent are fineable offenses. Voluntary compliance please, Thank You.



Please be good neighbors and inform your service providers of these concerns.

More winter to come! Snow removal from the streets evenly divided from the center of a road to the side of the same; we are an equal opportunity snow plowing department. Snow from driveways and sidewalks should remain on the property of origin; please do not place snow onto streets or other property other than your own.

Welcome to the holiday season! Hope your Thanksgiving was full of warmth and tidings spent with family and friends and that you get the Christmas Spirit and spread the joy of the season with all who are important to you...and even those who aren't.

PROPERTY TAX BILL INFORMATION

December 16th, 2019 is the statutory deadline for property tax bills to be mailed. If you have not received your property tax bill by December 18th, please call the village center at 608-244-3048.

Payments can be mailed or dropped off at the village center, 18 Oxford Place, Madison, WI 53704. Office hours are 7:30am-4:30pm Monday through Friday. The office will be closed on December 24th & 25th and January 1st. There is a payment box located in the vestibule of the village center if you are dropping off a payment after hours.

First installment payments are due by January 31, 2020 to the Village of Maple Bluff to avoid interest and penalties. Second installments are due to Dane County by July 31, 2020. If you want to include your property tax payment on your 2019 income taxes, that payment needs to be made on or before December 31, 2019. Please include the bottom portion of your tax bill when making payment.

DOG AND CAT LICENSING

The Village of Maple Bluff requires licensing of all dogs and cats kept within the village. Licenses will be available for purchase beginning December 16th and are valid for the 2020 calendar year. The cost for dogs is \$20.00 whether spayed/neutered or not. The costs for cats are \$12.50 for spayed or neutered pets and \$18.50 for un-spayed or un-neutered pets. You will also need to provide a copy of your pet's current rabies vaccination, with expiration date, when obtaining a license. Licenses can be obtained at the Village Center, 18 Oxford Place.



EMPLOYEE GIFT GIVING POLICY

The Village of Maple Bluff has an established policy regarding the acceptance of gifts by village employees. Maple Bluff Firehouse By Kristopher Loy

Response Data: The Maple Bluff Fire Rescue Department has responded to 107 emergency calls for service with an average response time of 4.18 minutes (dispatch to on scene) in 2019.

Kitchen Remodel: The MBFD is currently remodeling our kitchen/living room at the firehouse. This is the first update to these heavily utilized spaces since the Village Center was constructed 20 years ago. Our live-in interns, volunteers, and full-time staff use the kitchen and living room while we are on call at the firehouse. The remodel itself is being funded with the Village's Capitol Improvement fund. Thankfully this will cover the physical infrastructure (flooring, cabinets, plumbing, electrical, etc.), but we need your help. In an effort to provide our personnel with the comforts of home while volunteering their valuable time at the firehouse, we are asking for financial donations to help purchase new kitchen appliances, kitchen utensils, living room furniture, laundry, etc. If you're interested and/or willing to help the MBFD fund these items, please contact Chief Kristopher Loy 608-244-3390 or kloy@villageofmaplebluff.com.



Vegetation Fire: At approximately 10:30am on Sunday, November 10, 2019, our department was dispatched to a vegetation fire near the Maple Bluff Country Club's maintenance facility. Fire crews arrived on scene to find a 20ft x 40ft vegetation/compost pile with active fire present. Fire crews made their initial fire attack and simultaneously requested the assistance of the Maple Bluff Department of Public Works to help spread out the compost using a skid-steer. The fire was located in an area with limited fire hydrant access and crews laid over 400ft of supply hose to establish an adequate water supply. Fire crews were on scene for nearly two hours and able to sufficiently cool the smoldering compost. No firefighters or civilians were injured at this incident and the fire damage was contained to natural vegetation. No physical structures were damaged. We were assisted at the incident by the Maple Bluff Department of Public Works, Maple Bluff Police Department, and maintenance staff from the Country Club.
