## Notable Calls in the Village of Maple Bluff April 2023



## **Notable Calls in the Village**

The information provided below is about some of the call's officers responded to over the last month. Most narratives represent *early* and *preliminary* information that was gathered from those in the field who were actively working the cases. In many instances, facts and circumstances, even the type of crime listed, can change as the investigation unfolds.

**04/16: OWI 1**<sup>st</sup> **Offense – 2:07a.m.** Officer conducted a traffic stop on Commercial Avenue for a traffic violation. Field sobriety was conducted on the 36-year-old female driver. The driver was arrested for OWI (1<sup>st</sup> offense) and released to a responsible party.

**4/18: Assist Other Agency (Pursuit)** – **5:06a.m.** Monona K9 Officer located and pursued a vehicle stemming from a shots fired call in the City of Madison. MOPD Officers were joined by Maple Bluff PD who responded to assist via mutual aid, knowing the vehicle's occupants were just involved in a shooting in our Dane County community. The pursuit lasted for several miles traveling southbound on Hwy 51. Madison PD Officers was positioned along the route with tire deflation devices in an effort to slow the vehicle. The vehicle eventually came to a stop near Voges Rd at which point all occupants fled on foot. Monona Police and Maple Bluff PD gave chase. One occupant was later observed to be armed with a firearm as they fled from officers. Monona Police deployed K9 Jakko who immediately apprehended one subject. A Maple Bluff Police Officer was able to apprehend the driver of the stolen vehicle along with locating a firearm on the driver's seat of the stolen vehicle.

**04/21: OWI 1**<sup>st</sup> **Offense – 9:09p.m.** Officer conducted a traffic stop on Kensington Drive for a traffic violation. The 28-year-old male driver was arrested for OWI (1<sup>st</sup> offense) and held at the Dane County Jail on a 12-hour hold.

**04/24:** Eluding (Stolen Vehicle) – **12:30a.m.** Officer attempted to conduct a traffic stop on a vehicle for speeding at North Sherman Avenue and Lakewood Blvd. The vehicle refused to stop for the officer and a pursuit occurred. The 20-year-old female driver ended up fleeing the vehicle on foot and was not able to be apprehended. Officers detained two passengers from the vehicle and were able to identify the driver. The vehicle was later learned to be stolen and the driver was located by Middleton PD the next day and taken into custody for the charges of Eluding, Resisting/Obstructing a police officer and Operating a Motor Vehicle Without the Owners Consent.

**04/27: Disorderly Conduct/Resisting – 4:38p.m.** Officer was dispatched to Kensington Drive for an intoxicated 37-year-old male walking on foot and causing a disturbance. Police contact was made, and the subject was arrested and taken to Dane County Jail for Disorderly Conduct and Resisting a police officer.
