



Notable Calls in the Village of Maple Bluff July 2023

Notable Calls in the Village

The information provided below is about some of the call's officers responded to over the last month. Most narratives represent *early* and *preliminary* information that was gathered from those in the field who were actively working the cases. In many instances, facts and circumstances, even the type of crime listed, can change as the investigation unfolds.

07/08: Eluding/Reckless Endangerment (Pursuit) – 7:20pm. Officer observed multiple vehicles driving south on N. Sherman Avenue at a high rate of speed down traveling on both lanes of traffic. The officer attempted to catch up to the lead suspect vehicle but lost sight of it as it continued south on Fordem Avenue. The suspect vehicle was found at Fordem/Johnson Street as it was involved in a three-car accident at this intersection. The 21-year-old male driver fled the accident scene prior to the officer's arrival. The Madison Police Department assisted with the accident report and Maple Bluff PD has referred charges of Eluding and Reckless Endangerment and Hit & Run Causing Injury.

07/09: Arrest Person – 4:30pm. Officer was dispatched to Cambridge Road regarding an intoxicated male on foot causing a disturbance. Officer made contact and arrested the 30-year-old male for Disorderly Conduct and for Violation of Bail Conditions.

07/14: Operating While Intoxicated 1st Offense – 2:08am. Officer made a traffic stop on a vehicle driving without its head lamps activated. Officer arrested 53-year-old female for 1st offense OWI and cited the driver for multiple violations including open intoxicants in the vehicle.

07/15: Operating Motor Vehicle Without Owner's Consent – 12:32am. Officer received a lead from a reliable law enforcement resource of a stolen vehicle at N. Sherman and Oxford Place. Officer located stolen vehicle east on Commercial Avenue from N. Sherman Avenue. Three adult males (19-year-old) (17-year-old) (18-year-old) were arrested and had referred charges of Eluding, Resisting and Operating a Motor Vehicle Without Owner's Consent. A 14-year-old juvenile male had charges referred for Eluding, Resisting and Operating a Motor Vehicle Without Owner's Consent as a passenger.

07/17: Eluding/Reckless Endangerment (Pursuit) – 11:53pm. Officer attempted a traffic stop at N. Sherman and Roxbury Road. Vehicle refused to stop, and a pursuit was initiated. The suspect vehicle eventually stopped, the driver (23-year-old female) and passenger (23-year-old-female) were arrested and taken to Dane County Jail on referred charges of Eluding, Reckless Endangerment, Possession of Cocaine, and a Probation Hold.

07/22: Operating Motor Vehicle Without Owner's Consent – 7:13am. Officers received a lead from a reliable law enforcement resource of a stolen U-Haul truck at Lakewood Blvd and Fisk Place. Officers were able to stop the vehicle and arrested a 38-year-old male. Charges have been referred for Operating Motor Vehicle Without Owner's Consent, Possession of Drug Paraphernalia, Felony Bail Jumping. Driver was also cited for Operating a Commercial Vehicle While Suspended.

07/22: Arrested Person – 4:43am. Officer on routine patrol observed a suspicious male standing by the front entrance of the closed BP gas station at 1010 North Sherman Avenue. Officer made contact and during his investigation determined that the 40-year-old male was wanted through Madison PD for Burglary, Theft and Criminal Damage to Property. The male was arrested and taken to Dane County Jail.

07/26: Arrested Person – 10:59pm. Officer conducted a traffic stop at North Sherman and Fordem Avenue. The 43-year-old male driver was arrest for possession of THC and Felony Bail Jumping.

07/27: Arrested Person – 1:11am. Officer on routine patrol observed a 64-year-old female emerge from under a partially unsecured boat cover at the Maple Bluff Marina. The officer's investigation resulted in the arrest of the female for Resisting, Felony Bail Jumping and Burglary.
