Notable Calls in the Village

The information provided below is about some of the call's officers responded to over the last month. Most narratives represent *early* and *preliminary* information that was gathered from those in the field who were actively working the cases. In many instances, facts and circumstances, even the type of crime listed, can change as the investigation unfolds.

06/02: Eluding/Reckless Endangerment (Pursuit) – 7:20pm. Officer observed a vehicle traveling on Sherman Avenue at a radar confirmed speed of 56mph in a posted 25mph zone. The officer attempted to catch up to the suspect vehicle but lost sight of it as it continued north on North Sherman Avenue. The suspect vehicle was later found in the parking lot of 1102 N. Sherman where it had become disabled do to striking a parked pickup truck in the parking lot. All occupants in the suspect vehicle fled the scene west into the village. The 20-year-old male driver was eventually located and taken into custody in Fuller Woods. Both Maple Bluff and the Madison Police Department have referred charges of Eluding and Reckless Endangerment.

06/05: Drug Arrest – 8:30pm. Officer conducted traffic stop at North Sherman and Roxbury Road. During the traffic contact, the officer located Marijuana and multiple bottles of Promethazine. Promethazine abuse is common among injection drug users, patients with chronic pain, and at-risk teenagers. The 19-year-old male driver and 19-year-old male passenger were booked into the Dane County Jail with referred charges of Possession of THC and Possession W/ Intent to Deliver a Schedule V drug.

06/16: Eluding/Reckless Endangerment (Pursuit) – 10:17pm. Officer conducted traffic stop at North Sherman and Commercial Avenue. During the traffic contact, the officer observed and recovered a bottle of the drug Promethazine. During the traffic stop investigation, the driver and two passengers fled the scene by driving away form the traffic stop. A vehicle pursuit proceeded that was terminated due to lost sight of the suspect vehicle. The suspect vehicle was later located, unoccupied, at Aberg Avenue/Huxley St. The 35-year-old male driver had charges referred for Possession of illegally Obtained Prescription Drugs, Eluding and Reckless Endangering Safety. The 34-year-old male front passenger had referred charges for Possession of illegally Obtained Prescription Drugs. The 33-year-old male back passenger had referred charges of Obstruction and Eluding.

06/18: Assist Other Agency (Homicide) – 3:41am. Maple Bluff officers assisted Madison PD on Dayton Street regarding shots fired with a 20-year-old- male victim on scene who eventually

died due to the injuries sustained from the shooting. Maple Bluff assisted by checking the area for suspects and was unable to locate anyone. No other actions taken by our department and Madison PD is still investigating the incident to identify suspect(s).

06/25: Drug Arrest – 10:31pm. Officer conducted a traffic stop on N. Sherman. During the traffic contact, the officer recovered large amounts of THC Edibles, Marijuana, Meth and cocaine. The officer also recovered thousands of dollars in stolen construction equipment and department store clothing with tags still on them. The 44-year-old male driver was arrested and taken to the Dane County Jail on the referred charges of Possession W/ Intent to Deliver Meth, Possession W/ Intent to Deliver Cocaine, Possession of THC, Possession of Drug Paraphernalia and Resisting/Obstructing a Police Officer. Additional investigation is actively occurring to find the victims of the stolen property.
