## **Notable Calls in the Village**

The information provided below is about some of the call's officers responded to over the last month. Most narratives represent *early* and *preliminary* information that was gathered from those in the field who were actively working the cases. In many instances, facts and circumstances, even the type of crime listed, can change as the investigation unfolds.

**09/03: Operating Motor Vehicle While Intoxicated Arrest – 12:09am.** Officer made a traffic stop on N. Sherman Avenue for speeding. The officer investigated a suspicion of impairment along with a disturbance that had originated in the parking lot of the North Gate Shopping Center on North Sherman Avenue. The investigation resulted in the 44-year-old male driver being arrested for Operating a Motor Vehicle While Intoxicated (1st offense), Reckless Endangerment, Disorderly Conduct, Parole Violation and Speeding 20-24mph over the posted speed limit.

**09/06: Eluding/Reckless Endangerment – 12:37am.** An officer was working patrol and attempted a traffic stop at N. Sherman Avenue and Sherman Avenue. The vehicle refused to stop, resulting in a pursuit. The pursuit ended after a stop stick tire deflation device was used on the suspect vehicle resulting in it coming to a stop. A high-risk traffic stop was conducted, and the 26-year-old male driver was taken into custody. The arrested driver was taken to Dane County Jail on charges of Eluding, Reckless Endangerment, Possession with Intent to Deliver THC and Carrying a Concealed Weapon (firearm).

**09/07: Drug Activity/Drug Paraphernalia Recovery – 12:33pm.** Officer was dispatched Johnson Park regarding the observation of uncapped syringes found on the ground. Officer located multiple uncapped syringes in the park next to the entrance at N. Sherman/Lakewood Blvd. The drug paraphernalia was taken back to the police department and properly destroyed. Investigation to identify those responsible for disposing of the syringes is still on going.

**09/14:** Adult Arrested Person – 1:17am. Officer contacted a bicyclist in the 600 block of N. Sherman regarding riding in the roadway with no lights/reflectors. The 41-year-old male become uncooperative during the contact and was later discovered to be in possession of drug paraphernalia and cocaine. The suspect was taken to Dane County Jail on the referred charges of Possession of Cocaine, Possession of Drug Paraphernalia, Resisting/Obstruction, Felong Bail Jumping and Operating a cycle without required lights/reflectors.

**09/17: Operating Motor Vehicle While Intoxicated Arrest – 11:07pm.** Officer made a traffic stop on North Sherman Avenue in front of the Lakewood Plaza Shopping Center. The traffic stop investigation resulted in the arrest of the 55-yr-old female driver for Operating a Motor Vehicle While intoxicated (1st offense).

**09/30: Operating Motor Vehicle While Intoxicated Arrest – 4:24am.** Officer made a traffic stop on North Sherman Avenue/Roxbury Road. The traffic stop investigation resulted in the arrest of the 23-yr-old male driver for Operating a Motor Vehicle While intoxicated (1<sup>st</sup> offense).
