## Notable Calls in the Village of Maple Bluff February 2024



The information provided below is about some of the call's officers responded to over the last month. Most narratives represent *early* and *preliminary* information that was gathered from those in the field who were actively working the cases. In many instances, facts and circumstances, even the type of crime listed, can change as the investigation unfolds.

**02/02: Assist Other Agency – 4:10am.** MBPD responded as mutual aid for the Madison Police Department at an address on Monterey Drive regarding an active disturbance. Upon arrival, a male suspect was observed to be in possession of a firearm. Officers ordered the suspect to drop the firearm and he followed the instructions and was safely taken into custody. Madison PD arrested the suspect and has pending charges on him.

**02/03: Attempted Stolen Vehicle – 6:12pm.** MBPD responded to a cold scene attempt to steal a vehicle in the parking lot of the Lakewood Plaza. An investigation concluded that an unknown suspect broke the rear passenger window of the victim's vehicle, and the steering wheel was tampered with to attempt to steal the vehicle. No suspect has been identified in this case.

**02/03: Eluding/Reckless Endangerment – 9:29pm.** MBPD was given information regarding a vehicle not stopping after a traffic stop was initiated by the Dane County Sheriff's Office on Northport Drive. MBPD responded as mutual aid for setting up a tire deflation device and engaged in the pursuit until the suspect vehicle became disabled and the driver fled on foot. The 23-year-old male suspect was caught and taken to the Dane County Jail on charges for Eluding and Second-Degree Reckless Endangerment.

**02/13: Adult Arrest – 3:56pm.** MBPD investigated a red Pontiac G6 that had eluded multiple traffic stop attempts from Maple Bluff and Madison PD. MBPD was able to identify the driver and responded to the Dane County Court House where the 18-year-old male suspect was scheduled to appear for an unrelated criminal offense. The suspect was safely taken into custody at the courthouse and booked into the Dane County Jail on charges of Eluding, Reckless Endangerment, Felony Bail Jumping and Hit and Run.

**02/06: Assist Other Agency (Shooting) – 11:15pm.** MBPD responded as mutual aid for the Madison Police Department at the Locker Room Bar on Roth Street regarding a disturbance with shots fired in the parking lot. An investigation determined that suspects shot at the victim and then proceeded to steal the victim's vehicle and left the area before police arrival. The victim's vehicle was later located by MBPD on **Kensington Drive** in Maple Bluff with

multiple gun shots in the driver's side door/window. The suspects were not located, and the Madison Police Department processed the vehicle and had it towed to their evidence lot. Madison PD is still investigating this case to identify the suspects. No physical injury was reported regarding the people involved in this incident.

**02/08: Retail Theft – 11:08pm.** MBPD responded to Vic Pierce Liquor regarding a retail theft of alcohol. MBPD investigated and was able to identify the 15-yr-old juvenile suspect who was cited for retail theft.

**02/15:** Attempted Burglary/Trespassing – **5:32pm.** MBPD responded to a report of a potential burglary at a vacant home on Old Shore Road as the complainant had witnessed someone entering the home through an unsecured window. The interior of the home was checked and there was no suspect located. The window was secured, and no suspect has been identified.

**02/18: Assist Other Agency (shooting) – 10:00am.** MBPD was made aware by Madison PD of a disturbance/shooting on Vera Court. The suspect vehicle was last seen on N. Sherman/Northport Drive. MBPD checked the area and was unable to locate the suspect. Milwaukee PD eventually located the suspect/vehicle in their jurisdiction and the suspect was taken into custody without incident. No reported injury to those involved in this incident.

**02/27: Attempted theft from Autos – 3:41am.** MBPD responded to Fuller Woods for an attempted entry into a vehicle parked in the driveway of the residence. MBPD investigation concluded that a male wearing a hooded sweatshirt, face covering, and black backpack had attempted entry into vehicles at multiple addresses on Fuller drive/Fuller Court. No property was reported stolen, and the suspect has not yet been identified.
