## Notable Calls in the Village of Maple Bluff March 2024



The information provided below is about some of the call's officers responded to over the last month. Most narratives represent *early* and *preliminary* information that was gathered from those in the field who were actively working the cases. In many instances, facts and circumstances, even the type of crime listed, can change as the investigation unfolds.

**03/05: Hit and Run Accident – 12:34am.** MBPD observed multiple traffic signs run over and damaged on the raised divided median on North Sherman and Oxford Place. The investigation determined that the damage occurred from a hit & Run from a motor vehicle. Evidence recovered at the scene along with using department resources, the vehicle was identified, and the 68-year-old male driver was located and cited for hit and run.

**3/11:** Adult Arrest – 7:58pm. MBPD conducted a traffic stop at North Sherman/Roxbury Road. The non licensed driver was identified as being out on bail for a Hit & Run causing an injury accident. The driver's bail conditions prohibited him from operating a motor vehicle without a valid driver's license. As result, the 24-year-old male was arrested for bail jumping and taken to the Dane County Jail.

**03/12: Stabbing/Assist Outside Agency—7:59pm.** MBPD was requested as mutual aid to 1901 Aberg Avenue for a subject stabbed by a knife. MBPD assisted with rendering first aid to the victim. Madison PD is actively investigating this incident and no suspect(s) have been identified/taken into custody at this time.

**03/12:** Adult Arrest – 10:55pm. MBPD conducted a traffic stop at North Sherman/Sherman Avenue. During the traffic investigation, it was learned that the driver had two active criminal warrants for possession of cocaine and non-support. MBPD requested mutual aid for assistance and the 30-year-old male driver was arrested for his warrants and taken to the Dane County Jail without incident. The driver was also cited for Operating a Motor Vehicle with a Revoked Driving Status.

**03/13: Adult Arrest – 1:58am.** MBPD conducted a traffic stop at N. Sherman/Erie Street. The traffic investigation determined that the driver was out on bail for a Domestic Abuse arrest and the bail conditions restricted contact with the victim in that arrest. The female passenger in this traffic stop was identified as the victim in the domestic case and as result the 29-year-old male driver was arrested and taken to the Dane County Jail for the charge of Bail Jumping.

**03/23:** Adult Arrest – 2:00am. MBPD conducted a traffic stop at N. Sherman/Sherman Avenue. The traffic investigation determined that the driver had a probation/parole warrant and a 2<sup>nd</sup> warrant from Outagamie County for Disorderly Conduct. The 35-year-old male was arrested and transported to the Dane County Jail on the two warrants.

**03/27:** Adult Arrest (Gun/Knife Recovered) – 10:23pm. MBPD conducted a traffic stop after observing a violation at North Sherman/Commercial Ave. The traffic investigation determined that the driver was in violation of current bail conditions to not operate any motor vehicles. The MBPD officer requested back up from an outside agency and the driver attempted to flee the traffic stop. The vehicle became disabled due to a tire deflation device placed in front of the tires at the beginning of the traffic contact and, after a short foot pursuit, the suspect was quickly and safely taken into custody.

Search of the 33-year-old male suspect resulted in the finding of a concealed knife and further investigation determined that the suspect left a loaded handgun in the vehicle. The suspect was booked into the Dane County Jail on charges of Flee/Eluding, two counts of Felony Bail Jumping, 2nd degree Reckless Endangerment, Carrying a Concealed Weapon (knife), Resisting Arrest and Felon in Possession of a Firearm.

**03/29: Adult Arrest – 1:06am.** MBPD conducted a traffic stop at North Sherman/Roxbury Road. Traffic investigation determined that the 38-year-old male had an active warrant for non-support through Dane County. The driver was taken into custody and taken to the Dane County Jail.
