



# Maple Bluff Fire Rescue By the Numbers







It's hard to believe that spring is just around the corner! Daylight saving time will begin on March 9, 2025. The Maple Bluff Fire Rescue Department wants to remind the community to check their smoke and carbon monoxide alarms.

If your home has battery-operated smoke or carbon monoxide alarms, it is time to change the batteries. Hardwired smoke detectors may also have a battery backup, so it is important to change those backup batteries as well. Many new alarms come with batteries that last up to 10 years. After 10 years, the entire smoke detectors will need to be replaced. It is also recommended to test all detectors every month. While testing your smoke alarm, conducting a fire exit drill with all family members is a great practice. Ready.gov is an excellent resource for learning about creating a home fire escape plan and preparing for all disasters and emergencies.

According to the National Fire Protection Association, smoke detectors save lives and play a vital role in reducing fire-related deaths and injuries. Here are some important statistics regarding smoke alarms:

- Almost three out of every five home fire deaths occur in homes that lack smoke alarms or have non-working smoke alarms.
- The risk of dying in a home fire is cut in half in homes with functioning smoke alarms.
- Smoke alarms provide early warning and additional time to escape during a fire, increasing your chance of survival by 50%.

## **Department of Public Works**

Dear Village Residents,

We have a significant water department project underway that will continue until completion. This includes the renewal of our aging water meter reading heads, field collection equipment, billing software, and more. While we've made good progress, we need to accelerate our efforts. You will receive detailed information on who, what, where, when, why, and how this project will unfold. The success of this upgrade depends on acquiring and installing the necessary hardware, and your participation in the installation process will be crucial. We appreciate your cooperation and look forward to improving our system.

Winter took an extended vacation through December and January, but February brought it back in full force. We've seen a modest amount of snow, some freezing rain, and plenty of cold. Thank you to those who keep your sidewalk and driveway snow on your own property. Unfortunately, some service providers push driveway snow into the street, creating problems for neighbors. Please remind your snow removal service that this is prohibited under Ordinance 192-6 B.

During the slower winter months, we focused on cleaning and restoring the appearance of the Village Center entrance floor and the Beach House floors, bathrooms, and kitchen. Regular maintenance is essential to keeping these spaces clean and inviting.

By the time you receive this newsletter, our tree maintenance and removal efforts should be underway. We've been pruning young trees and lifting the lower branches of struggling spruce trees. Colorado Spruce, in particular, don't thrive in our humidity, but raising the canopy should help-time will tell.

Though winter may linger a bit longer, we're already looking ahead to spring. Groundhog predictions are only 30-40% accurate, so don't put too much stock in them! We're likely to see more snow, but hopefully, more snow than black ice. And of course, we still have to get through Boys Basketball tournament season before spring officially arrives.

Think Spring!



#### Open Gym

Use of the gym is available through the key fob program or by exclusive rental. Please adhere to the below rules during your use:

- Key fob users may bring up to 3 guests per user.
- Users with more than 3 guests may reserve the gym. Same day reservations are not allowed.
- Users under 12 must be accompanied by an adult.
- No food, drink, or gum allowed.
- No street shoes allowed.
- No using foul/obscene language.
- No dunking/hanging on the rim.
- No lowering of Basketball hoops without written consent of Recreation Department.
- Put all equipment away and notify Village staff of any problems or broken equipment.
- Disposal of dirty diapers is prohibited.
- Violations of rules may result in the revocation of key fob privileges.
- Respect others and be courteous. If the gym is full, users may play games together or half court games. Limit half court games to one hour.

**Hours:** The gym is available 7-days a week from 8am – 9pm. Please check the Village's Parks and Recreation calendar for availability.

# The gym will be closed March 31<sup>st</sup> and April 1<sup>st</sup> for the Election.

The gym will offer exclusive Toddler Open Gym Monday - Friday from 8:00am - 11:00am, unless schools are cancelled or scheduled off.

The gym will also offer exclusive Pickleball Hours from 11:00am - 1:00pm Monday - Friday, unless no school. The Village gym has pickleball lines and a portable net. Users are suggested to bring their own paddles and balls.

Why am I seeking another term on the Village Board after a six-year

Maple Bluff is a special place and, as residents, we are fortunate to have our own municipal government so we can keep it that way. Village residents are active and engaged in this community. #### LAURA PECK

Hello Neighbors! My name is Laura Peck and I am running for Village Trustee. I have lived in the neighborhood since 1999 with my husband, Greg Anderson. We raised our two children here and are proud to call Maple Bluff home. Over the last 25 years we have participated in many activities, valuing fun traditions that make Maple Bluff special such as Camp Ya Gotta Wanna,

Arts and Athletics, sports and rec teams, pool swims, Father's Day parades, Bocce and Fest on the 4th. I am a business attorney with the Axley Brynelson law firm in Madison specializing in finance and real estate. Here in Maple Bluff, I previously served for years as the Chair of the Village Police and Fire Committee (back when it was one committee), and two stints on the Village Plan Commission, including currently. As part of the Plan Commission, we are now deep in the review of the draft updated zoning code. I am also very active in the Rotary Club of Madison, TEMPO Madison and the Overture Center for the Arts. In my spare time I enjoy walking, concerts, reading, and travelling. Ask me where our next trip is!

# How do you view the role of local government generally, what should it prioritize, and how should it operate?

There used to be a saying, "All politics is local." These days, national politics often dominates the conversation, but there is still excellent value in local government. In Maple Bluff our politics remain grounded in local concerns, built on consensus, tradition, and mutual respect. Our local board reflects the relationships we share with our neighbors. Its primary responsibility is to be responsive to and honor our community, and to ensure the delivery of essential services in a fiscally responsible manner. Looking ahead, our priorities should focus on implementing the results of the recent referendum, updating our codes, using tools such as the Tax Incremental District (TID) to improve our quality of life, and fostering a sense of neighborhood pride and a welcoming atmosphere for all. I would also prioritize ensuring our staff is compensated at competitive market rates while strengthening our administrative functions through technology and thoughtful hiring decisions.

#### What do you consider the top priorities for the Village of Maple Bluff, and how would you work with staff and officials to help pursue them?

The top priority for the village remains fiscal responsibility. We are not alone there. Many municipalities have begun using referenda to finance the services they provide due to the constraints put on local governments by the state legislature. This tool is necessary but should be used infrequently and as a last resort, in my view.

The new draft zoning code is an example of how we can modernize our regulations to ease the administrative process while continuing to protect our village character. Most of us only have dealings with the village when we pay our taxes and want to put in a patio/shed/fence. Kudos to the task force that spent the last year meticulously updating the code that we are now reviewing. Look for a public hearing in the next few months to see the improved code. I encourage you all to review and provide feedback. Let's look for other opportunities to implement similar updates.

The last priority I'll address is the tension between the wonderful services provided by the village and the cost and organizational structure we use to provide them. I do not see any big changes needed here, but it is always a good idea to keep the big picture in mind when making incremental decisions.

#### Why are you running for Village Trustee?

I enjoyed my work with the Plan Commission and Police and Fire Committee. I am proud of the impact these groups have had on our community. I am at a place in my life where I can now devote more time to give back and hope that my skill set might be useful. I promise to listen thoughtfully, consider all sides and vote my conscience. I would be honored to represent my neighbors as a Village Trustee.



#### SCOTT ROBINSON

Introduction that includes educational, professional, civic, and volunteer experiences.

My wife Amy and I were married in Madison in 1984. Amy grew up in Maple Bluff, and we moved back to her childhood home in 2019. We met at UW-Madison while I was in the Naval ROTC program, majoring in Economics. After graduation, I served in the Navy for 30 years, retiring as a Captain

in 2012, and then another three years with the military as a civilian Chief of Staff. The highlights of my Navy career were my command tours as captain, leading the Sailors of the destroyer USS SPRUANCE (DD-963) and the cruiser USS ANZIO (CG-68).

Between shipboard assignments and a dozen home moves, I earned an MBA in finance from the University of California, Irvine. I completed tours of duty in the Pentagon offices of the Navy Comptroller, Headquarters US Marine Corps, Joint Chiefs of Staff, Office of the Secretary of Defense, and Chief of Naval Operations, specializing in budget development and analysis, strategic planning, major acquisition programs, and contracting. I have six years of start-up and cyber warfare experience as the first Chief of Staff of Fleet Cyber Command/Tenth Fleet and also the first Chief of Staff of the Cyber National Mission Force, the operational force under US Cyber Command.

In the past few years, I was President of the UW-Madison Naval ROTC Alumni Association, during which we rewrote our bylaws, created a brand-new website, and grew our membership.

# How do you view the role of local government generally, what should it prioritize, and how should it operate?

I believe the Village Board's primary responsibility is to promote and sustain the general welfare of the residents of Maple Bluff. The Village must maintain independence as a municipality, support an effective police force, balance tax levies with services, and address citizen concerns. My observation is that the governance of our Village, with policy set by the Board and execution by the Village staff, is functioning well and we have much to be proud of. I do, however, think there should be more discussion about the future Village and an annual town hall meeting.

#### What do you consider the top priorities for the Village of Maple Bluff, and how would you work with staff and officials to help pursue them?

To shape the future Village, I have three specific ideas.

First, the time is right to explore potential alternatives to our alignment with the Madison Metropolitan School District (MMSD). We don't appear to receive an educational experience that most Village parents support. Only about a dozen Maple Bluff children from an estimated K-12 population of over 220 attend MMSD, while most parents pay tuition for alternatives. This marks a complete reversal from the 1960's when most Village children attended MMSD schools, and the exception was a child enrolled in a private school. A Maple Bluff school district would allow us direct control of the education of Village children, create a more cohesive environment for children, eliminate the expense of private tuition, effectively leverage and retain our property taxes, and establish a school board composed of neighbors. These potential benefits, in my view, outweigh any arguments in favor of maintaining alignment with MMSD.

Any initiative of independence from MMSD presents several issues.

- **Sentiment** Does the Village support this concept or is the status quo acceptable? A referendum to determine this would need to be developed and placed on the ballot.
- **Fiscal** With the approved MMSD referendum, we will be sending \$7-8 million in property taxes to MMSD for the next 25 years. This funding level would support the operation of a small school district and the construction of a school and facilities.
- **Legal** We lack standing for independence without a Board of Education (BoE). If a referendum on school independence passes, a BoE must be elected.
- **Execution** We would need volunteer support with legal, architectural, financial, educational, and planning skills to contribute to this effort. It's a multi-year process that is not simple but also not impossible. We have the expertise in the Village.

The second issue I want to address is the structure of tax referendums. Last fall's referendum did not clearly communicate the anticipated duration of the initiative. I believe future property tax referendum should be proposed for five years duration before a new referendum is considered. I would work with Village staff to craft any future tax referendum to accomplish this. Tax referendums with a defined minimum duration benefit the common good by providing relative stability, especially to those on relatively fixed incomes.

Finally, we need to create a tree management policy for Village-owned trees. In 2023, the Village paid for a comprehensive tree inventory, but the policies that should guide our canopy and tree management remain unwritten. I would work with Public Works to draft a policy document for public comment.

Why are you running for Village Trustee?

I am grateful to live in Maple Bluff. Amy and I enjoy tennis in the summer and paddle in the winter, and we volunteer/ donate at the Bocce event each year. I enjoy music (Radio Paradise!) and riding a Tacx trainer with Rouvy.

Serving as a Trustee would continue a family tradition of service. Amy's grandfather, George, was the second Village Clerk and served from 1931 to 1951. Amy's father, Bill, was the longest-serving Village President from 1971 to 1979. He also served as the Village Attorney from 1987 to 2007 while concurrently holding office as the President of the Village EMS District from 1979 to 2011.

While I will never reach those levels of tenure, I ask for your vote this April and look forward to shaping the future of Maple Bluff.



#### JIM SCHULER

Introduction that includes educational, professional, civic, and volunteer experiences.

I grew up in Golden Valley, Minnesota within sight of downtown Minneapolis in a neighborhood a lot like Maple Bluff. After getting my BA at Carroll College and MFA at the University of Massachusetts, I moved to Madison, met Marvel (who grew

up on the northside and went to East High School) and a few years later moved from the Atwood neighborhood into our home at 340 Lakewood Blvd. That was 1988: our daughter Zoe was 4 and our son Sam, who would be born in 1990, was still in R&D.

What drew us to the Bluff was its proximity to Lake Mendota, our parks and visual openness, and the sense of community we saw as we watched neighbors stopping to talk to each other as they walked through the neighborhood. We loved Madison-but Maple Bluff felt different, family-friendlier, better. That's what I've worked to maintain with many of you to in my over 30 years on various committees, as a past village president and as a trustee. I also represent the Village with the Dane County Cities and Villages Associate (DCCVA) and I am also a DCCVA-appointed commissioner on the Capital Area Regional Planning Commission (CARPC)

#### Why are you running for Village Trustee?

I'm running again because I enjoy working with my neighbors to make a difference. And we do. I think I've been a particularly productive trustee and committee chair because I'm good at identifying and enlisting neighbors with particular skill sets—whether that's an architect to design the Dailey Cabin or a cross country skier (who's also a longstanding member of the MBCC Greens Committee) to plan and groom the winter trails.

I also get things done. My first proposal to the Village Board in 1989–even before I joined the Parks Committee– showed how adding a pier and in-water storage spaces at the Marina could generate revenue for that and other parks. That led to me joining and ultimately chairing the Parks Committee, and tackling a parks infrastructure that hadn't been updated or improved in half a century. In order to fund those, we initiated the Fourth Fest Fun Run in 1999, and the Bocce Beach Bash in 2003. Over the past 25 years, we've rebuilt the Beach House, the Marina building and the Dailey Cabin. We've raised more than \$250K to redesign and reequip all our parks and rec facilities, finance the grooming equipment for the cross country and snowshoe trails, and develop more programming for all age groups.

When we created the Tax Incremental District in 2014, I assumed the chairmanship of the Plan Commission and helped lead us through a difficult but productive three years of getting Lakewood II and the Gordon approved, developed and generating incremental revenue. During the same period, I also initiated discussions with Maple Bluff Country Club as to how the Village could help its fundraising efforts to rebuild the pool in exchange for getting more residents access to the pool and, ultimately, raise the percentage of Village households with country club memberships. That was formalized in the new lease I signed as Village president in 2015. While we still haven't reached our goal of 50% plus of Village households with country club memberships that involve pool access, we're much closer than we were ten years ago.

For the past two years, I've chaired the "Zoning Ordinance Update Steering Committee" that's gone through the painstaking process of reviewing, analyzing and updating our 100 plus pages of zoning ordinance. The Steering Committee had its final meeting in January and the Public Hearing will be April 15th. I hope you'll get a chance to review the proposed changes on the Village website.

# How do you view the role of local government generally, what should it prioritize, and how should it operate?

The role of our government, besides providing basic services, is to deliver on the vision documented in our Comprehensive Plan and our Comprehensive Outdoor Recreation Plan as cost-efficiently as possible. Because of our size, we have and should set the standard for responsiveness to neighbor needs, whether that's with snow removal, EMS response, or clarifying contradictory zoning regulations.

If we're going to continue to be an independent village for another century (we'll celebrate our 100th birthday in 2028), we need to not just prioritize, but commit to finding ways to continue to provide the same quality and range of all services without raising property taxes more than the rate of inflation.

That means continued fundraising for parks and recreation, researching more grant opportunities, exploring more equipment savings by participating in shared purchase agreements and, maybe most importantly, continued and enthusiastic volunteerism.

One of the reasons we've been so successful is because there's not a hard line between our residents and our government. While "many hands make light work," many neighbors working together also build relationships that make for a tighter, more cohesive and prosperous community.

#### What do you consider the top priorities for the Village of Maple Bluff, and how would you work with staff and officials to help pursue them?

- 1. "Beta-test" the new zoning ordinance and tweak as necessary. Help develop the necessary forms to make applications as clear and simple as possible.
- 2. Strategically plan and manage our budget to stay at or below the rate of inflation without sacrificing the quality of our services or over-extending staff.
- 3. Make sure the new front-office reorganization is successful. Replacing two valuable and long-serving employees is tough, but it's also an opportunity.

- 4. Get the Gateway Plan going. The benefits aren't just aesthetic-they could also help solve some of our traffic safety issues and help fund some necessary infrastructure improvements.
- 5. Put together an ad-hoc grant-writing group. I've learned a couple of things since becoming more active with DCCVA and CARPC: there's a lot of money out there and our staff doesn't have the time to go after it. If you have any grant-writing experience-or are willing to learn-give me a call.
- 6. Doing all of the above while keeping our growth in property values above surrounding communities, kee[ping our property taxes at or below those of neighboring municipalities and maintaining our AAA bond rating.

## Water Meter Transition

As you may know, our Public Works Department is working diligently to upgrade the meters in over 500 homes in our community. Given our small team and the administrative burden of the existing meters, we are looking to expedite installations with resident support to ensure a more efficient process. We appreciate your patience and cooperation as we proceed with this important project.

#### Why Are We Replacing Water Meters?

- The new meters improve accuracy, reliability, and efficiency in water usage tracking.
- They eliminate the need for manual readings, reducing administrative time and costs.
- They enhance leak detection, helping residents monitor water usage more effectively.
- The DNR requires the replacement of meters within 20 years of installation.

#### Addressing Concerns About RF Signals

Some residents have expressed concerns about radiofrequency (RF) emissions from the new meters. Please know:

- The RF exposure from these meters is extremely low-far lower than that of common household devices like Wi-Fi routers, cell phones, and baby monitors.
- The meters transmit data for only a few seconds per day, meaning exposure is minimal.
- The National Cancer Institute and CDC have conducted extensive studies on RF exposure, and there is no conclusive evidence linking low-level RF emissions to health risks.
