



Notable Calls

Maple Bluff Police Department January 2025

The information provided below summarizes some of the incidents that officers responded to over the past month. Please note that most narratives reflect initial and preliminary details gathered by personnel in the field at the time of the incident. As investigations progress, the facts, circumstances, and even the classification of the incidents may change.

1/2/25: Assist Outside Agency 11:25pm (Eluding) – While on routine patrol, an MBPD officer became aware of a vehicle eluding incident initiated by an outside agency. The MBPD officer responded to the area via mutual aid and located the suspect vehicle on STH 51 at HWY 30. The vehicle disregarded the officer's visual and audible signals, then fled at increased speeds, engaging the officer in a vehicle pursuit. After traveling approximately 13.1 miles the suspect vehicle came to a stop after striking multiple tire deflation devices. The 34-year-old male driver and a 22-year-old male passenger were taken into custody after a brief struggle. The suspects were turned over to the investigating agency to face charges related to the initial pursuit.

1/4/25: Assist Outside Agency 1:59pm (Weapons Offense) – While on routine patrol, an MBPD officer became aware of a weapons call within the jurisdiction of an outside agency. The suspect was reported to be in crisis, armed with a handgun, and was holding it to his head. An MBPD negotiator responded via mutual aid to the scene to provide assistance with de-escalation. Upon arrival, contact was initiated with the subject, and a verbal dialogue ensued. The 25-year-old male suspect was taken into custody after the application of less lethal interventions and was turned over to the outside agency for processing.

1/9/25: Assist Outside Agency 10:56pm (Eluding) – While on routine patrol, MBPD officers became aware of a vehicle eluding incident initiated by an outside agency. The MBPD officers responded to the area via mutual aid and located the suspect vehicle on N Sherman Ave and Aberg Ave. The vehicle disregarded the officer's visual and audible signals, then fled at increased speeds, engaging the officers in a vehicle pursuit. After traveling approximately .5 miles the suspect vehicle came to a stop after striking a curb. The 34-year-old male driver was taken into custody after a brief foot chase. The suspect was turned over to the investigating agency to face charges related to the initial pursuit.

1/19/25: Traffic Arrest 2:45am (Recovered Stolen Auto) – While on routine patrol, an MBPD officer obtained information from a reliable law enforcement resource that a stolen automobile was operating within the village. The MBPD officer responded to the area and located the stolen vehicle at the intersection of Lakewood Dr and Farwell Dr. The vehicle initially stopped for the officer's visual and audible signals; however, upon receiving verbal commands to exit the automobile, the driver reengaged the vehicle's transmission and fled at low speeds. After traveling approximately .1 miles the suspect vehicle came to a stop on a dead-end street. The 37-year-old male suspect was taken into custody after a brief struggle. The suspect was transported to the

Dane County jail on charges of Operating a Motor Vehicle Without Owners Consent (OMWOC), Flee/Elude, and a Parole Violation.

1/31/25: Investigation 7:03pm (Theft from Auto) – While on routine patrol, MBPD officers were dispatched to a theft from auto complaint at an address within the village. Upon arrival, officers made contact with the vehicle owner, who reported that an unknown suspect had forced entry into his vehicle, rummaged through their belongings, and stole an undetermined amount of money. This investigation remains ongoing.

1/31/25: Assist Outside Agency 7:50pm (Adult Arrest) – While on routine patrol, MBPD officers became aware that an outside agency was at a business in the village, attempting to arrest a violent assault suspect. It was also learned that this suspect had 14 warrants for their arrest. The 35-year-old male suspect was taken into custody on charges of Mayhem, Battery, and his numerous arrest warrants. The suspect was also placed on an Immigration hold.
