



Notable Calls

Maple Bluff Police Department February 2025

The information provided below summarizes some of the incidents that officers responded to over the past month. Please note that most narratives reflect initial and preliminary details gathered by personnel in the field at the time of the incident. As investigations progress, the facts, circumstances, and even the classification of the incidents may change.

2/1/25: Assist Outside Agency 1:19am (Fight in progress) – An MBPD officer responded to 1145 N. Sherman Avenue via mutual aid reference a large fight occurring in the parking lot and inside the business of Hayes Place. When MBPD and Madison Police Department arrived, the fighting had ended, and vehicles were leaving the parking lot. MBPD remained in the area until the crowd had fully dispersed.

2/4/25: Assist Outside Agency 9:10pm (Check Person) – An MBPD officer responded via mutual aid to the intersection of McGuire and Fordem Avenue regarding an intoxicated 23-year-old female standing in traffic yelling for help. MBPD arrived on scene and took the female into protective custody. The female was then turned her over to the Madison Police Department with no further action taken by MBPD.

2/6/25: Traffic Stop 1:52am (Eluding) – While on routine patrol, an MBPD officer attempted to initiate a traffic stop on N. Sherman Avenue. The vehicle came to a stop on Michigan Court and the driver fled the vehicle on foot prompting the officer to request mutual aid assistance. The Madison Police Department and Dane County Sheriff's Office responded to the scene. A drone was deployed for aerial surveillance. Additionally, Madison's K9 unit assisted in the search. The 29-year-old male driver was eventually taken into custody and charged with Obstructing and Disorderly Conduct.

2/8/25: Accident, Hit & Run 9:07am – While on routine patrol, an MBPD officer located a traffic sign down at N. Sherman Avenue and Oxford Place. The investigation is still ongoing to identify the suspect vehicle/driver.

2/9/25: Traffic Arrest 11:24pm (Adult Arrest) – While on routine patrol, an MBPD officer initiated a traffic stop on a vehicle with an unassociated plate near 615 North Sherman Avenue in the Village of Maple Bluff. Upon activation of emergency lights and sirens, the driver initially refused to stop but eventually pulled over at the 2400 block of Hoard Street in the City of Madison. Attempts to communicate with the driver were unsuccessful. Due to safety concerns and the potential for heightened risk, mutual aid was requested, and officers from multiple agencies responded to assist. More information about the details of this incident can be found in the MPBD Public Information Release dated 10 February 2025. Upon taking the subject into custody, officers identified him and confirmed that he had four active warrants for offenses including 3rd & 4th offense driving while intoxicated, multiple counts of Bail Jumping, Resisting, Battery/Threat to Law Enforcement, Disorderly Conduct, Operating After Revocation, and tampering with and ignition interlock device.

The 39-year-old male suspect was booked into the Dane County Jail without further incident on the following additional charges:

- Eluding (Misdemeanor) 346.04 (2)
- Resisting (Misdemeanor) 946.41(1)
- Resisting – Substantial Harm (Felony) 946.41(2)(r)
- Battery to Law Enforcement (Felony) 940.20(2)
- Failure to Comply w/ Attempt to Take into Custody (Felony) 946.415(2)
- Bail Jumping (Felony) 946.49 (1)(b)

2/16/25: Assist Outside Agency 1:25am (Adult Arrest) – While on routine patrol, MBPD officers were dispatched to assist the Dane County Sheriff’s Office via mutual aid regarding a pursuit of a stolen vehicle. An MBPD officer was able to respond and assist with a high-risk traffic stop at Stoughton Road and Milwaukee Street on the suspect vehicle. The 19-year-old male driver was taken into custody without incident. There were no MBPD charges from this arrest.

2/25/25: Traffic Arrest 2:01am (Adult Arrest) – While on routine patrol, an MBPD officer attempted to initiate a traffic stop on N. Sherman Avenue. The vehicle disregarded the officer's visual and audible signals, then accelerated to higher speeds, engaging the officer in a vehicle pursuit. The fleeing vehicle eventually came to a stop in the 2300 block of Monterey Drive, where the 58-year-old-male driver was taken into custody after a high-risk stop was conducted. The suspect was transported to the Dane County jail on charges of Flee/Elude and cited for Operating While Revoked and Violating a Red Traffic Signal.

02/26/25: Traffic Arrest 2:01am (Juvenile Arrest/Eluding) – An MBPD officer assisted Madison Police Department via mutual aid at Aberg Avenue and Packers Avenue. While at the intersection, the MBPD officer observed a vehicle traveling at 45mph over the posted 25mph speed limit. The vehicle disregarded the officer's visual and audible signals, engaging the officer in a vehicle pursuit. The fleeing vehicle eventually came to a stop at Packers Avenue and Northport Drive where the 16-year-old-male driver was taken into custody after a high-risk stop was conducted. The driver was transported to the Dane County Juvenile Retention Center on charges of Flee/Elude, Unreasonable and Imprudent Speed and cited for Operating a Motor Vehicle Without a Valid Driver’s License.

2/28/25: Traffic Arrest 12:09am (Adult Arrest) – While on routine patrol, an MBPD officer conducted a traffic stop at N. Sherman Avenue and Oxford Place. The traffic stop investigation resulted in the arrest of the 58-year-old female driver for Operating a Motor Vehicle While Intoxicated (2nd offense). The driver was also cited for Operating a Motor Vehicle While Revoked.
