



# Notable Calls

## Maple Bluff Police Department

### March 2025

*The information provided below summarizes some of the incidents that officers responded to over the past month. Please note that most narratives reflect initial and preliminary details gathered by personnel in the field at the time of the incident. As investigations progress, the facts, circumstances, and even the classification of the incidents may change.*

**3/14/25: Assist Outside Agency 1:28am (Eluding)** – A MBPD officer responded to Hwy 30 and Stoughton Road via mutual aid reference a pursuit by Monona PD. A tire deflation device was used to disable the vehicle and MBPD assisted with the high-risk stop of the vehicle. The 24-year-old female driver was arrested and taken to jail by Monona PD.

**3/14/25: Assist Outside Agency 10:37pm 9:10pm (Eluding/Stolen Vehicle)** – MBPD officers responded via mutual aid to the 1400 block of Northport Drive for a report of a stolen vehicle. MBPD located the stolen vehicle, and the vehicle disregarded the officer's visual and audible signals, then accelerated to high speeds, engaging the officer in a vehicle pursuit. The pursuit ended after the vehicle became disabled and five occupants fled on foot. One of the occupants was located and taken to Dane County Jail. The 23-year-old male passenger was booked under the charges of Operating a Motor Vehicle Without Owner's Consent-Passenger & Possession of a Firearm by a Felon. The investigation is ongoing.

**3/15/25: Traffic Stop 1:52am (Eluding)** While on routine patrol, an MBPD officer attempted to initiate a traffic stop on N. Sherman Avenue. The vehicle disregarded the officer's visual and audible signals, then accelerated to higher speeds, engaging the officer in a vehicle pursuit. The MBPD officer recognized unfavorable conditions and terminated the pursuit. The suspect vehicle was later located disabled and one of the occupants was taken into custody. The 27-year-old male passenger was taken to the Dane County Jail on charges of Possession of a Firearm by a Felon & Resisting. The 30-year-old male driver was identified, and charges were referred for Eluding, 1<sup>st</sup> Degree Reckless Endangerment and Hit & Run to an occupied vehicle.

**3/19/25: Disturbance 8:56pm** – While on routine patrol, a MBPD officer was dispatched to an address in the Village of Maple Bluff regarding a possible physical disturbance. MBPD officer was working alone requested mutual assistance from Madison PD. Upon arrival, the investigation found no active disturbance occurring. The MBPD Officer conducted mediation between the individuals involved and resolved the matter, no arrests were made.

**3/20/25: Check Residence 3:00pm** – While on routine patrol, an MBPD officer was dispatched to an address in the Village of Maple Bluff regarding a citizen coming home and finding a door standing open into the residence. The MBPD officer arrived and checked the interior of the home to find no signs of an intruder. It was determined that no unauthorized entry was made into the home.

**03/29/25: Traffic Arrest 4:18pm** – A MBPD officer conducted a traffic stop on N. Sherman Avenue on a vehicle with no front/rear registration plates. The traffic stop resulted in the arrest of the 23-year-old male driver for Obstruction/refusing to identify himself.
