

Notable Calls

Maple Bluff Police Department April 2025

The information provided below summarizes some of the incidents that officers responded to over the past month. Please note that most narratives reflect initial and preliminary details gathered by personnel in the field at the time of the incident. As investigations progress, the facts, circumstances, and even the classification of the incidents may change.

4/01/25: Traffic Arrest 5:50am (Warrant) – An MBPD officer conducted a traffic stop in the 600 block of N. Sherman Avenue. The investigation resulted in the arrest of the 49-year-old male driver for a bench warrant out of Illinois.

04/03/25: Traffic Stop/Citation & Release 9:05pm (Drugs/Ammunition recovered) – An MBPD officer conducted a traffic stop in the 600 block of N. Sherman Avenue. The investigation resulted in the recovery of a small amount of marijuana along with a loaded pistol and rifle magazine. No actual firearms were recovered. The driver of the vehicle was cited and released.

04/05/25: Traffic Arrest 11:06pm (Warrant Arrest) – An MBPD officer conducted a traffic stop in the 400 block of N. Sherman Avenue. The investigation resulted in the arrest of the 28-year-old female driver for multiple active warrants including Operating a Motor Vehicle Without Owners Consent, Bail Jumping, Possession of Cocaine, Theft, and Possession of Drug Paraphernalia.

04/10/25/18/25: Assist Other Agency 1:58am (Physical Domestic in Progress) – An MBPD officer was requested via mutual aid to assist the Madison Police Department (MPD) for the report of a female being physically assaulted. The MBPD officer assisted with locating/arresting the 40-year-old male suspect that had fled the scene of the assault. The MPD booked the suspect into the Dane County Jail for multiple charges including Domestic Battery, Intimidation, False Imprisonment, Disorderly Conduct, Resisting, and a Probation Violation.

04/10/26: Traffic Arrest 5:35pm (Wanted Subject) – An MBPD officer was given information from the MPD regarding a wanted subject in the area. The 47-year-old male suspect was recently involved in a domestic incident and known to be in possession of two firearms. The MBPD officer located the suspect/vehicle in the 400 block of N. Sherman Avenue. A high-risk traffic stop was conducted, and the suspect was taken into custody without incident. The suspect was turned over to the MPD and taken to the Dane County Jail on domestic related charges.

04/20/25: Traffic Arrest 8:13pm (Operating M/V While Intoxicated) – An MBPD officer observed a motor vehicle traveling at a speed of 60mph in the 600 block of N. Sherman Avenue. A traffic stop was conducted, and the investigation resulted in the arrest of the 27-year-old driver for Operating a Motor Vehicle While Intoxicated.

04/25/25: Traffic Arrest 8:58pm (Eluding) – An MBPD officer attempted to conduct a traffic stop in the 600 block of N. Sherman Avenue. The vehicle disregarded the officer's visual and audible signals, then accelerated to higher speeds, engaging the officer in a vehicle pursuit. The MBPD officer recognized unfavorable conditions and terminated the pursuit. The MBPD officer utilized law enforcement resources to identify the 22-year-old male driver and the 24-year-old male passenger. The driver was arrested and taken to the Dane County Jail on charges of Eluding and Resisting/Obstructing. The passenger had charges referred for Eluding-Passenger and Resisting/Obstructing.
