The information provided below summarizes some of the incidents that officers responded to over the past month. Please note that most narratives reflect initial and preliminary details gathered by personnel in the field at the time of the incident. As investigations progress, the facts, circumstances, and even the classification of the incidents may change.

06/04/25: Traffic Arrest 7:20pm (Warrant) – An MBPD officer conducted a traffic stop at N. Sherman/Sherman Avenue with a motor vehicle. The traffic stop investigation resulted in the arrest of the 24 year-old male driver for a warrant out of Jefferson County, Wisconsin. The driver was also cited for operating a motor vehicle while revoked.

06/04/25: Traffic Arrest 9:51pm (Warrants) – An MBPD officer conducted a traffic stop at N. Sherman/Lakewood Blvd with a motor vehicle. The traffic stop investigation resulted in the arrest of the 22 year-old male driver for multiple warrants and the 41 year-old male passenger was arrested for multiple warrants. The driver was also cited for operating a motor vehicle without a valid driver's license.

06/05/25: Traffic Arrest 8:02pm (Bail Violation) – An MBPD officer conducted a traffic stop at North Sherman/Lakewood Blvd with a motor vehicle. The traffic investigation resulted in the arrest of the 45 year-old male driver for violation of his bail conditions. The driver was also cited for operating a motor vehicle while revoked.

06/07/25: Traffic Arrest 2:00am (Eluding) – MBPD officer attempted to conduct a traffic stop at 615 N. Sherman Avenue with a motor vehicle. The vehicle disregarded the officer's visual and audible signals, engaging the officer in a short pursuit. The vehicle eventually stopped, and the 60 year-old female driver was arrested for operating a motor vehicle while intoxicated—2nd offense, eluding, and having a prohibited alcohol concentration.

06/09/25: Traffic Arrest 11:48pm (Eluding) – An MBPD officer attempted to conduct a traffic stop on N. Sherman Avenue/Roxbury Road with a motor vehicle. The driver disregarded the officer's visual and audible signals and accelerated to higher speeds, engaging the officer in a vehicle pursuit. The vehicle eventually came to a stop and the 36 year-old male driver was arrested for eluding, 1st degree reckless endangerment, and a probation violation hold. The driver was also cited for operating a motor vehicle while revoked.

06/12/25: Traffic Arrest 6:27pm (Bail Violation) – An MBPD officer conducted a traffic stop at North Serman/Lakewood Blvd with a motor vehicle. The traffic investigation resulted in the arrest of the 23-year-old female driver for violation of her bail conditions. The driver also was cited for operating a motor vehicle while revoked and having illegal window tint.

06/12/25: Traffic Arrest 11:10pm (Eluding) – An MBPD officer attempted to conduct a traffic stop on N. Sherman Avenue/Commercial Avenue with a subject operating a moped. The operator

disregarded the officer's visual and audible signals and accelerated into the parking lot of 615 N. Sherman Avenue. The moped was found abandoned in the rear alley at 615 N. Sherman Avenue. The 29 year-old male operator was located and arrested for eluding and resisting/obstructing. The operator was also cited for non-registration and operating a motor vehicle while revoked.

06/14/25: Traffic Arrest 9:19pm (Warrant) – An MBPD officer conducted a traffic stop at N. Sherman/Fordem Avenue with a motor vehicle. The traffic stop investigation resulted in the arrest of the 41 year-old male driver for a Department of Correction Probation Warrant.

06/17/25: Traffic Arrest 12:40am (Eluding) – An MBPD officer attempted to conduct a traffic stop on N. Sherman Avenue/Lakewood Blvd with a motor vehicle. The driver disregarded the officer's visual and audible signals and accelerated to higher speeds, engaging the officer in a vehicle pursuit. The vehicle eventually became disabled, and the driver fled on foot. The 29 year-old driver was found a few minutes later and arrested for eluding, 2nd degree reckless endangerment, prohibited alcohol concentration—3rd offense, resisting/obstructing, and bail jumping. The driver was also cited for operating a motor vehicle while revoked and unreasonable and imprudent speed.

06/20/25: Traffic Arrest 6:59pm (Drugs) – An MBPD officer conducted a traffic stop at N. Sherman/Commercial Avenue with a motor vehicle. The traffic stop investigation resulted in the arrest of the 37 year-old male driver for possession with intent to deliver—THC, and possession of cocaine. The driver was also cited for operating a motor vehicle without a valid driver's license.

06/21/25: Traffic Arrest 6:01pm (Probation Violation) – An MBPD officer conducted a traffic stop at Lakewood Blvd/Cambridge Road with a motor vehicle. The traffic stop investigation resulted in the arrest of the 24 year-old male driver for a probation violation and threats to a law enforcement officer. The driver was also cited for operating a motor vehicle without a valid driver's license and violating a traffic signal.

06/24/25: Traffic Arrest 6:55pm (Warrant) – An MBPD officer conducted a traffic stop at N. Sherman/Roxbury Road with a motor vehicle. The traffic stop investigation resulted in the arrest of the 38 year-old male driver for a warrant through Columbia County.

06/25/25: Traffic Arrest 11:38pm (Warrant) – An MBPD officer conducted a traffic stop at N. Sherman/Commercial Avenue with a motor vehicle. The traffic stop investigation resulted in the arrest of the 18 year-old male driver for a warrant through the City of Madison.
