

Notable Calls

Maple Bluff Police Department July 2025

The information provided below summarizes some of the incidents that officers responded to over the past month. Please note that most narratives reflect initial and preliminary details gathered by personnel in the field at the time of the incident. As investigations progress, the facts, circumstances, and even the classification of the incidents may change.

07/01/25: Traffic Arrest 11:56pm (Eluding) – An MBPD officer attempted to conduct a traffic stop at 615 N. Sherman Avenue. The vehicle disregarded the officer's visual and audible signals, engaging the officer in a vehicle pursuit. The pursuit ended when the suspect stopped the vehicle and attempted to flee on foot. The 55-year-old driver was detained and placed under arrest for Possession of Cocaine, Eluding, Resisting, Reckless Endangerment, Hit and Run to a parked vehicle, and a Parole Violation. The driver was also cited for Operating a Motor Vehicle While Revoked.

07/02/25: Traffic Arrest 8:15pm (Warrant) – An MBPD officer conducted a traffic stop at N. Sherman/Sherman Avenue. The traffic stop investigation resulted in the arrest of the 31-year-old male driver for a Probation Warrant.

07/05/25: Traffic Arrest 3:00am (OWI 2^{nd} Offense) – An MBPD officer conducted a traffic stop at North Sherman/Sherman Avenue. The traffic investigation resulted in the arrest of the 31-year-old female driver for Operating a Motor Vehicle While Intoxicated – 2^{nd} Offense.

07/06/25: Traffic Arrest **12:30am** (Recovered Stolen Vehicle) – An MBPD officer attempted to conduct a traffic stop on a stolen vehicle involved in a shooting in Wauwatosa County at N. Sherman/Roth Street. The vehicle disregarded the officer's visual and audible signals, engaging the officer in a vehicle pursuit. The pursuit was terminated due to the officer losing visual of the suspect vehicle. The suspect vehicle was later found unoccupied and was held until Wauwatosa County was able to take custody of it. The driver/occupants of the stolen vehicle were not located.

07/06/25: Traffic Arrest 11:24pm (OWI 1st **Offense)** – An MBPD officer conducted a traffic stop at North Sherman/Roxbury Road. The traffic investigation resulted in the arrest of the 33-year-old male driver for Operating a Motor Vehicle While Intoxicated – 1st Offense.

07/07/25: Traffic Arrest 11:48pm (Probation Violation) – An MBPD officer conducted a traffic stop at Lakewood Blvd/Cambridge Road. The traffic investigation resulted in the arrest of the 37-year-old male driver for a Probation Violation and citations for Operating a Motor Vehicle While Revoked, Suspended Registration, and Unreasonable/Impudent Speed.

07/08/25: Traffic Arrest 12:24am (Warrant) – An MBPD officer conducted a traffic stop at N. Sherman/Roxbury Road. The traffic stop investigation resulted in the arrest of the 22-year-old female driver for a warrant.

07/10/25: Traffic Arrest 6:50pm (Drugs) – An MBPD officer conducted a traffic stop at Sherman/McGuire Street. The traffic stop investigation resulted in the arrest of the 26-year-old male driver for Possession with Intent to Deliver (THC), Disorderly Conduct, Resisting Arrest, Child Endangerment and Threats to Law Enforcement.

07/11/25: Disturbance 11:14pm (Warrant Arrest) – An MBPD officer was dispatched to the Lakewood Plaza Shopping Center regarding an active disturbance. The investigation resulted in the arrest of a 32-year-old male for 2 active warrants.

The traffic stop investigation resulted in the arrest of the 29-year-old male driver for Operating a Motor Vehicle While Intoxicated – 4th Offense and Possession of Cocaine. Citations were issued for Traffic Signal and Seatbelt violations.

07/19/25: Traffic Arrest 1:41am (Obstructing) – An MBPD officer conducted a traffic stop at North Sherman Avenue/Oxford Place. The traffic stop investigation resulted in the arrest of a 31-year-old male for Obstructing.

07/19/25: Traffic Arrest 6:55pm (Parole Violation) – An MBPD officer conducted a traffic stop at 615 N. Sherman Avenue. The traffic stop investigation resulted in the arrest of the 64-year-old male driver for a Parole Violation.

07/21/25: Traffic Arrest 11:44pm (Warrant Arrest) – An MBPD officer conducted a traffic stop at N. Sherman/Commercial Avenue. The traffic stop investigation resulted in the arrest of the 41-year-old male driver for a Bench Warrant.

07/22/25: Assist Other Agency 4:16am (Shooting/Homicide) – An MBPD officer responded via mutual aid to a shooting incident as 2110 Schlimgen Avenue. The MBPD officer was the first officer on scene and immediately began rendering medical care to the 30-year-old male victim. The victim later died from his injuries. Madison PD has taken a person of interest into custody regarding this incident.
