



Notable Calls

Maple Bluff Police Department

August 2025

The information provided below summarizes some of the incidents that officers responded to over the past month. Please note that most narratives reflect initial and preliminary details gathered by personnel in the field at the time of the incident. As investigations progress, the facts, circumstances, and even the classification of the incidents may change.

08/02/25: Traffic Arrest 11:03pm (Warrant) – An MBPD officer conducted a traffic stop at N. Sherman Ave/Roxbury Road. The investigation resulted in an arrest of the 39-year-old male driver for a warrant (battery / disorderly conduct) through the Dane County Sheriff's Office.

08/04/25: Traffic Arrest 11:37pm (Warrant) – An MBPD officer conducted a traffic stop at N. Sherman Ave/Roxbury Road. The investigation resulted in an arrest of the 25-year-old female driver for a warrant (operating after revocation) through the Jefferson County Sheriff's Office.

08/9/25: Traffic Arrest 12:27am (Warrant) – An MBPD officer conducted a traffic stop at N. Sherman Ave/Roxbury Road. The investigation resulted in an arrest of the 35-year-old male driver for an extraditable felony parole warrant. The driver was also cited for resisting/obstructing a police officer and operating a motor vehicle without a valid driver's license.

08/15/25: Theft From Auto 11:10am (Stolen license plate) – An MBPD officer was dispatched to the area of Warner Drive regarding a theft from auto complaint. The investigation determined that a front license plate was stolen off a vehicle sometime overnight. No suspects have been identified.

08/15/25: Traffic Arrest 10:40pm (X2 Warrants) – An MBPD officer conducted a traffic stop at N. Sherman Ave/Roxbury Road. The investigation resulted in an arrest of the 30-year-old male passenger for a two bench warrants (disorderly conduct w/ use of a dangerous weapon and possession of cocaine) through the Dane County Sheriff's Office. The passenger also had charges referred for misdemeanor bail jumping and resisting/obstructing a police officer.

08/17/25: Traffic Arrest 11:57pm (Probation Violation) – An MBPD officer conducted a traffic stop at 616 N. Sherman Ave. The investigation resulted in an arrest of the 47-year-old female driver for a Probation Violation. The driver also had charges referred for misdemeanor resisting / obstructing a police officer.

08/23/25: Traffic Arrest 11:50pm (OWI-1st Offense & Intoxicated Use of a Firearm) – An MBPD officer conducted a traffic stop after observing suspicious behavior in the parking lot of 1010 N. Sherman Avenue (Citgo Gas Station). The investigation resulted in an arrest of the 25-year-old male driver for Operating a Motor Vehicle While Intoxicated - 1st Offense. The driver also had charges referred for Intoxicated Use of a Firearm.

08/25/25: Traffic Arrest 7:19pm (Warrant) – An MBPD officer conducted a traffic stop at Sherman Ave/McGuire Street. The investigation resulted in an arrest of the 19-year-old female driver for a warrant (operating without a valid driver's license) through the Jefferson County Sheriff's Office. The driver was also cited for illegal window tinting.

The investigation resulted in an arrest of the 41-year-old male driver for Operating a Motor Vehicle While Intoxicated - 1st Offense. The driver was also cited for a headlight violation.

The investigation resulted in an arrest of the 27-year-old male driver for an extraditable felony warrant (unauthorized use of identifying information and obstructing an officer) through the Dane County Sheriff's Office.
