

Notable Calls

Maple Bluff Police Department October 2025

The information provided below summarizes some of the incidents that officers responded to over the past month. Please note that most narratives reflect initial and preliminary details gathered by personnel in the field at the time of the incident. As investigations progress, the facts, circumstances, and even the classification of the incidents may change.

10/04/25: Traffic Arrest 12:49am (OWI 4th) – An MBPD officer was exiting Kelly's Market Gas Station on Shopko Drive when they observed a vehicle exhibiting signs of reckless driving and possible impairment. The officer initiated a traffic stop near Shopko Drive and Highway 30. However, the driver failed to comply with the officer's visual and audible signals, leading to a brief pursuit. The vehicle eventually stopped at Aberg Avenue and East Washington Avenue, where the driver was taken into custody. The investigation led to the arrest of a 61-year-old male for Operating a Motor Vehicle While Intoxicated (4th offense). The driver was additionally charged with Eluding, Reckless Driving, Unreasonable and Imprudent Speed, Failure to Obey a Traffic Signal, and a Probation Violation.

10/04/25: Traffic Incident 11:03pm (Eluding) – An MBPD officer conducted a traffic stop near North Sherman Avenue and Roxbury Road. During the stop, the 37-year-old male driver fled in his vehicle. The vehicle quickly became disabled near Fordem Avenue and Johnson Street, where the driver fled on foot and was not located. Charges of Eluding and Obstruction have been referred to the District Attorney's Office.

10/11/25: Traffic Arrest 3:12am (Assist Other Agency) – An MBPD officer provided mutual aid to the Dane County Sheriff's Office during a pursuit of a stolen vehicle on Northport Drive in Madison. The suspect's vehicle became disabled after officers deployed a tire deflation device, and the suspect was taken into custody. The juvenile male driver was transported to the Juvenile Reception Center by the Dane County Sheriff's Office and faces charges of Operating a Motor Vehicle Without the Owner's Consent and Obstructing Law Enforcement.

10/12/25: Adult Arrest 1:18am (OWI 1st) – An MBPD officer observed a traffic violation at N. Sherman and Oxford Place and conducted a traffic stop. The investigation resulted in an arrest of the 40-year-old female driver for Operating a Motor Vehicle While Intoxicated - 1st Offense. The driver was also cited for Unsafe Lane Deviation.

10/15/25: Adult Arrest 1:00am (Possession of THC) – An MBPD officer conducted a traffic stop at N. Sherman Ave/Sherman Avenue. The investigation resulted in an arrest of the 27-year-old female driver for possession of 28 grams of THC.

10/23/25: Adult Arrest 11:27pm (Warrant) – An MBPD officer conducted a traffic stop at N. Sherman Ave/Commercial Avenue. The investigation resulted in an arrest of the 54-year-old male driver for a warrant (probation violation) from the Department of Corrections and a second warrant (non-support) through the Dane County Sheriff's Office.

10/31/25: Adult Arrest 12:52am (Warrant) – An MBPD officer conducted a traffic stop at N. Sherman Ave/Sherman Avenue. The investigation resulted in an arrest of the 42-year-old male driver for an extraditable warrant (possession of THC) from White Water Police Department.
