



# Notable Calls

## Maple Bluff Police Department

### November 2025

*The information provided below summarizes some of the incidents that officers responded to over the past month. Please note that most narratives reflect initial and preliminary details gathered by personnel in the field at the time of the incident. As investigations progress, the facts, circumstances, and even the classification of the incidents may change.*

**11/10/25: Traffic Arrest 1:14am (Assist Other Agency/Eluding)** – An MBPD officer assisted the Madison Police Department via mutual aid regarding a vehicle fleeing from a traffic stop. The MBPD officer located the vehicle at East Washington Avenue/Hwy 30. A vehicle pursuit occurred which was quickly ended due to the successful deployment of a tire deflation device. The 41-year-old male driver was taken into custody and charged with Eluding and Possession with Intent to Deliver (THC).

**11/12/25: Adult Arrest 5:07pm (Assist Other Agency/Weapons Offense)** – An MBPD officer assisted the Madison Police Department (MPD) via mutual aid on Calypso Road regarding a disturbance of a male pointing a firearm at another male. The investigation resulted in an MPD arrest of a 61-year-old male for Possession of a firearm while intoxicated, Disorderly Conduct, Reckless Endangerment and Resisting Law Enforcement.

**11/13/25: Traffic Incident 11:52pm (Warrant)** – An MBPD officer conducted a traffic stop at N. Sherman Ave/Roxbury Road. The investigation resulted in an arrest of the 57-year-old male driver for a warrant (probation violation) from the Department of Corrections.

**11/15/25: Traffic Arrest 11:56pm (Warrant)** – An MBPD officer conducted a traffic stop at N. Sherman Ave/Roxbury Road. The investigation resulted in an arrest of the 31-year-old male driver for four bench warrants (Intimidation of a Victim, Strangulation, Battery, Disorderly Conduct) from the Dane County Sheriff's Office.

**11/21/25: Adult Arrest 11:46pm (Warrant)** – An MBPD officer conducted a traffic stop at Kensington Dr/Oxford Pl. The investigation resulted in an arrest of the 41-year-old male driver for a criminal warrant (Violation of Harassment Restraining Order) from the Dane County Sheriff's Office. Additionally, charges of Possession of Cocaine and Possession of Drug Paraphernalia were referred to the Dane County District Attorney's Office.

**11/25/25: Adult Arrest 1:00am (OWI 3<sup>rd</sup> Offense)** – An MBPD officer conducted a traffic stop at N. Sherman Ave/Sherman Avenue. The investigation resulted in an arrest of the 37-year-old female driver for OWI 3<sup>rd</sup> Offense. The driver was also cited for operating a vehicle with revoked driving status.
