The information provided below summarizes some of the incidents that officers responded to over the past month. Please note that most narratives reflect initial and preliminary details gathered by personnel in the field at the time of the incident. As investigations progress, the facts, circumstances, and even the classification of the incidents may change.

12/02/25: Traffic Incident (Warrant Arrest), 10:46 PM – An MBPD officer conducted a traffic stop at N. Sherman Avenue and Oxford Place. The investigation resulted in the arrest of a 35-year-old male driver on two active bench warrants (Battery and Disorderly Conduct) issued by the Dane County Sheriff's Office.

12/11/25: Traffic Arrest (OWI 4th Offense), 11:08 PM – An MBPD officer attempted a traffic stop in the 600 block of North Sherman Avenue. The vehicle failed to yield despite visual and audible signals and engaged the MBPD officer in a vehicle pursuit. The pursuit ended when the suspect stopped the vehicle and attempted to flee on foot. The 36-year-old male driver was taken into custody and charged with Eluding, OWI 4th Offense, Second-Degree Reckless Endangerment, Possession of Fentanyl, Resisting Law Enforcement, Failure to Install an IID, Operating While Revoked, and multiple outstanding warrants (OWI 3rd, Possession of Cocaine, Operating While Revoked, False Imprisonment, Battery, and Disorderly Conduct). Additionally, a 41-year-old male passenger was taken into custody on multiple warrants (Forgery, Bail Jumping, and Resisting)

12/14/25: Adult Arrest (Assist Other Agency / OWI 1st Offense), 2:10 AM – An MBPD officer assisted the Dane County Sheriff's Office via mutual aid regarding a vehicle fleeing from a traffic stop near Highway 30 and South Stoughton Road. The vehicle was located on South Stoughton Road, and a brief pursuit occurred before the suspect pulled into an apartment parking lot and surrendered. The 29-year-old male driver was taken into custody and charged with Eluding, OWI 1st Offense, and Operating a Motor Vehicle Without a Valid Driver's License.

12/15/25: Traffic Incident (Assist Other Agency / Eluding), 1:11 AM – An MBPD officer assisted the Dane County Sheriff's Office and Wisconsin State Patrol via mutual aid regarding a vehicle fleeing from a traffic stop at Highway 30 and Stoughton Road. The vehicle was located at Packers Avenue and Highway 30. A brief pursuit ended after a tire deflation device was successfully deployed. The 19-year-old male driver was taken into custody and charged with Eluding.

12/27/25: Traffic Arrest (Warrant Arrest), 1:39 AM – An MBPD officer conducted a traffic stop at N. Sherman Avenue and Oxford Place. The investigation resulted in the arrest of a 19-year-old female driver on an active warrant for Retail Theft issued by Winnebago County.
