



Notable Calls

Maple Bluff Police Department

January 2026

The information provided below summarizes some of the incidents that officers responded to over the past month. Please note that most narratives reflect initial and preliminary details gathered by personnel in the field at the time of the incident. As investigations progress, the facts, circumstances, and even the classification of the incidents may change.

01/01/26: Traffic Arrest (OWI 1st), 3:41AM – An MBPD officer was dispatched to a one car vehicle accident in the 1000 block of Farwell Drive. The traffic investigation resulted in an arrest of the 24-year-old female driver for Operating a Motor Vehicle While Intoxicated - 1st Offense. The driver was also cited for Failure to Keep a Vehicle Under Control and Open Intoxicants in a Vehicle.

01/02/26: Traffic Arrest (Felony Bail Jumping), 2:51PM – An MBPD officer observed a traffic violation at N. Sherman Avenue/Roxbury Road and conducted a traffic stop. The traffic stop investigation resulted in the referral of charges of the 31-year-old male driver on a bail violation of Possession of Narcotics (marijuana).

01/07/26: Traffic Arrest (CCW-Firearm), 4:55PM – An MBPD officer conducted a traffic stop at N. Sherman Avenue and Sherman Ave. The traffic investigation resulted in the arrest of a 30-year-old male driver for having a concealed firearm located inside the vehicle. The driver did not possess a CCW permit.

01/09/26: Traffic Incident (Assist Other Agency/Eluding), 10:15PM – An MBPD officer assisted the Madison Police Department (MPD) via mutual aid regarding a traffic stop where the suspect vehicle had rammed a Madison squad car and fled the scene. MBPD assisted MPD as they pursued the suspect vehicle. The vehicle became disabled and three occupants were taken into custody (27-year-old-male, 22-year-old-male, 29-year-old-male). No MBPD charges were referred to the DA's office from this incident as MPD was the primary arresting agency.

01/15/26: Traffic Arrest (Warrant), 11:57PM – An MBPD officer observed a traffic violation at N. Sherman Avenue and Commercial Ave and conducted a traffic stop. The investigation resulted in the arrest of a 37-year-old male driver on an active warrant for Non-Support issued by Dane County. The driver was also charged with Obstructing Law Enforcement.

01/18/26: Traffic Arrest (OWI-1st), 1:56AM – An MBPD officer was assisting an outside agency as mutual aid regarding a vehicle that fled from a traffic stop. The MBPD made a traffic stop on a possible match of the suspect vehicle at Stoughton Road/USH 51. The traffic investigation resulted in an arrest of the 35-year-old male driver for Operating a Motor Vehicle While Intoxicated - 1st Offense. The driver was also cited for Operating a Motor Vehicle While Suspended and Unreasonable/Imprudent Speed.

01/21/26: Traffic Arrest (Eluding), 11:22PM – MBPD officer attempted to conduct a traffic stop at N. Sherman Ave/Roxbury Rd. The vehicle disregarded the officer's visual and audible signals, engaging the officer in a pursuit. The vehicle pursuit ended when the vehicle became disabled due to a tire deflation device used by MPD. The 37-year-old male driver was arrested for Eluding, 2nd Degree Reckless Endangerment, Probation Violation and an active warrant through Green County for Non-Support.

01/30/26: Traffic Arrest (Assist Other Agency/Eluding), 12:41AM – An MBPD officer assisted the Dane County Sheriff's Office and Wisconsin State Patrol via mutual aid regarding a vehicle fleeing from a traffic stop at the I-90 Interstate and Hwy 30. MBPD located the vehicle at Highway 30 and Stoughton Rd. A brief pursuit ended after the driver stopped the vehicle and surrendered to police. The 24-year-old male driver was taken into custody and charged with Eluding.

01/31/26: Traffic Arrest (OWI-1st), 11:36PM – An MBPD officer observed a traffic violation at N. Sherman and Oxford Place and conducted a traffic stop. The traffic investigation resulted in an arrest of the 36-year-old female driver for Operating a Motor Vehicle While Intoxicated - 1st Offense.
